## **Grand Chapter Awards**

The Grand Chapter of Royal Arch Masons of Kansas has the ability to bestow several awards. These awards are given at the discretion of the Grand High Priest at the annual communication each year. While the Grand High Priest bestows the awards, it is up to each Companion within the Chapter to nominate worthy candidates for these honors and awards.



#### **Distinguished Service Medal (Bronze)**

This is an annual Grand Chapter award which is intended to recognize the leadership, commitment, and resolve of companions that dedicate their time to ensure the bond of their word; that establish all their actions and deeds as honorable; and demonstrate unyielding faithfulness to the tenets of Royal Arch Masonry. #### **Grand Chapter Sweetheart Award**

This award is intended to show our ladies how much we appreciate all the support they provide which allows us to continue our masonic journey throughout capitular masonry. ## 2023 South Central Chapter Meeting

The 2023 South Central meeting of Arch Masons was held September in Branson, Missouri. This was another excellent time for Royal Arch Masons from across the South Central Region to gather together, enjoy fellowship, and learn what each Grand Chapter within the region is doing in their jurisdiction. The Grand Chapter of Kansas was well represented. The South Central Region is made up of Grand Chapters from Arkansas, Kansas,





Louisiana, Missouri, Oklahoma, and Texas, and meets in different member states on a rotational basis. The next South Central meeting will be held September 20-21, 2024, in Tulsa, Oklahoma. It is open to any Royal Arch Mason and it is a good time to learn from our Companions what is working within their jurisdictions and to make long-lasting friendships.

## New Perpetual Life Membership Program

At the 2023 Grand York Rite Sessions, the delegates approved a measure allowing the Grand Recorder to present a new program for perpetual life memberships which could be paid over time rather than as one large lump-sum payment. The Grand Recorder met with the PPLM Committee and they are happy to report there is a new program allowing our members to pay their PPLM for the three York Rite bodies (Chapter, Council, Commandery) over a time period.

For a member to take part in the Perpetual Life Membership Payment Plan, they must be current on dues for the term or year for which the payment plan is started or requested.

The Payment Plan payment amount will equal thirty-five (35) times the amount of the annual dues for the constituent York Rite bodies (Chapter, Council, and Commandery) plus \$35.00 for a Life Sponsorship in the Knight Templar Eye Foundation.

The dues for the member will be frozen at the current amount during the active payment period of the Plan.

The Payment Plan monthly amount will be collected for a period of sixty (60) monthly installments. The installment amount will be determined by multiplying the annual dues by 35, plus \$35.00 Eye Foundation



Sponsorship (if not already obtained). That number will be divided by 60 monthly installments. (Example: Annual dues of (\$100.00 X 35)+\$35 will equal \$58.92 per month for 60 months).

The Member's annual dues will be paid by the Payment Plan during the time the installments are collected. Once the installment payments are completed, the member will receive a Perpetual Life Membership in the bodies on the original Installment Application.

If a member defaults on their installment plan for a period of more than 90 days, the Payment Plan will be considered cancelled, and any amount collected will be used to pay the member's annual dues until the balance is exhausted.

If the member desires to continue the Payment Plan between the 90 days of late installments, and up to one (1) year past the time of cancellation, the Payment Plan may be reinstated by calculating the remaining payment amounts and resuming the collection of monthly installments at the new rate. (The new rate will be calculated by using the amount remaining to be collected on the original Payment Plan and dividing it by the number of remaining months of the original plan.)

If the member's installment payments become more than one (1) year in arrears, the Payment Plan may be restarted by recalculating the installment payments. (The new rate will be calculated by using the current annual dues amount, subtracting the balance on hand in the member's account, and dividing by sixty (60) monthly installments.)

The Payment Plan may be paid off at any time. There will be no penalties applied for early payment to the Plan.

Lump sum payments may be made to the Payment Plan account. Payments will be recalculated for the remaining months of the Original Plan.

If a member becomes deceased before the completion of the Payment Plan, the amount remaining in the account will be used to purchase a Perpetual Memorial Membership for the deceased member.

If a member loses the right to membership, such as suspension from a prerequisite body, all payments will be forfeited to the Payment Plan.

#### The Sword and the Trowel

The emblematic sword and trowel are used and referred to in many of the different Masonic degrees and appendant bodies, but nowhere is it more prominent than when used in the Council of Cryptic Masons in the York Rite.

It has been said the Israelites who were engaged in the rebuilding of the temple executed their labors with the sword in one hand and the trowel in the other. This reference is in the Biblical account which stated while they were engaged in building the temple for the Great Architect of the Universe, they should also be ever ready to engage in battle. The symbolism of the sword as displayed in this form of operative masonry is in reference to the need to defend their lives, land, liberty and religion from those who would invade, steal and oppress them. The trowel's use is that of every operative mason who is engaged in construction. Simply put, it is used to spread cement and to make the building solid and sturdy in its constituent make up.

In speculative masonry, we are admonished in the Masters degree to use the trowel to spread the cement of brotherly love, by whose use will unite us into a sacred society of brothers. By this unity, we are encouraged to have no enmity or quarrel, since we are all united in one common goal, the pursuit of knowledge and enlightenment and the advancement of the great purposes of masonry among ourselves and the world.

In the Council, both the sword and trowel are prominent. In the various degrees of the Council, the sword is used to demonstrate the need to be ever on guard against those who would betray our trusts and confidence and the trowel is there to remind us to continually strive to build relationships with those in our midst. By building these strong relationships we can rest assured the sword should never have to make an appearance in our defense.

Both the sword and the trowel serve important roles in masonic ritual and symbolism. They appear in several degrees and bodies to serve a specific purpose, but their ultimate purpose should be to remind us to be ever vigilant against the enemies of masonry. Those enemies would use their power, authority and influences to deprive mankind of truth and knowledge. The true mason should be mindful of these interlopers who seek to block the minds of the people from free thought and free speech. It is our duty as masons to continue the great advancement of our Rites. By looking to both the sword, as the implement of knowledge and truth, and the trowel, as a symbol of perseverance, we should be able to strive toward our ultimate goal of spreading light and knowledge to all who desire to seek after it. This will enable us to bring both knowledge and enlightenment to the world around us and by doing so, will free the minds of the people from oppression.
